OPENING AND CLOSING INFORMATION AND FEES

Effective July 15, 2009

ALL OPENING AND CLOSINGS REQUIRE 24 HOURS MINIMUM NOTICE.

Sunset Memorial Park requires next of kin to personally come to our cemetery office 24 hours prior to the day of the service to sign and "Interment Authorization Form".

OPENING AND CLOSING HOURS

No openings and closings will be made on Sundays or Holidays.

THE FOLLOWING HOURS ARE GATE ARRIVAL TIMES:

WEEKDAYS 3:00 P.M. to 4:30 P.M. - Additional \$ 295.00

SATURDAY 9:00 A.M. to 12:00 P.M. - Additional 195.00

SATURDAY 12:00 P.M. to 3:00 P.M. - Additional 395.00

ALL GRAVE INTERMENTS INCLUDE THE PLACEMENT OF A TENT AND CHAIRS.

Sunset reserves the right not to erect a tent and/or place chairs if weather conditions could create a hazard, or the location of the grave does not allow space for a tent.

GRAVE INTERMENT *Adult and Child Casketed Remains* **\$950.00**

An outer burial container/vault is required for all casketed grave interments. Only one casketed remains (outer container/vault over 36" inches long) is permitted in a standard grave space.

Infant Remains - Section 27 "Babyland" **No Charge**

Infant burials in all other areas will be at the specified rate for that area. Maximum length of the infant burial container cannot exceed 36 inches. All Infant Sections have specific requirements for bronze memorials. If space permits an infant may be interred with an existing adult grave interment. See "SECOND RIGHT OF INTERMENT".

CRYPT GARDEN ENTOMBMENT *All Lawn Crypt Openings* **\$950.00**

Cremated remains and infants cannot be interred on top of Lawn Crypts. All Lawn Crypt Gardens have specific requirements for size and design of Bronze memorials. Personal Memory Vases and Government Memorials are not permitted in Lawn Crypt Gardens.

MAUSOLEUM ENTOMBMENT *All Mausoleum Crypt Openings* **\$950.00**

Embalming is required for all Mausoleum entombments. Sealer caskets are not to be sealed in the Mausoleums. An additional fee of \$250.00 will be charged for labor and casket protection when a grave disinterment is transferred to a mausoleum crypt.

CREMATED REMAINS *Grave Interment and Niche Inurnments* **\$750.00**

Grave Interment of Cremated Remains

One or two cremated remains may be interred in an Urn Garden grave. All Urn Gardens have specific requirements for size and design of bronze Memorials. Personal Memory Vases and Government Memorials are not permitted in Urn Gardens. Two Cremated remains may be interred/entombed in a standard grave or crypt space.

One cremated remains may be interred/entombed with one casketed interment/entombment in a standard individual grave space or crypt space if Sunset determines that sufficient space is available. However, if a bronze memorial or crypt lettering already exists, additional moralization for the cremated remains may not be permitted. See "SECOND RIGHT OF INTERMENT".

All Niche Inurnments **\$750.00**

Before a permanent container or urn is offered for cremated remains, all niche sizes and any specific requirements should be verified with the Sunset Office.

SECOND RIGHT OF INTERMENT/DOUBLE INTERMENT

One Half (1/2) the Current Property Price

A second right of interment charge applies when a second interment or entombment of remains is placed in a single grave or crypt. Sunset, in its sole judgment, will determine if there is sufficient space for the second interment or entombment. Bronze Memorial options are limited for all second/double interments or entombments. SECOND RIGHT OF INTERMENT must be written on a Sunset contract.

RECORDING FEE **125.00**

The office recording fee is included with each opening and closing fee. However, when one casket with one cremated remains, one casket with an infant, or two cremated remains, are placed at the same time in the same space, the charge will be one opening and closing fee plus one recording fee.

CHAPEL INFORMATION AND FEES

The Westwood Abbey Chapel, Sunset Chapel and Banquet Rooms are for the exclusive use of the property owners of Sunset Memorial Park and the funeral director of their choice.

These facilities are available for visitation, committal services, memorial services and banquet receptions. The Chapels and Banquet Rooms will be reserved in the order they are requested by the family or funeral director.

In order to accommodate the individual needs of all families and funeral directors, Sunset reserves the right to select the appropriate area, within the Chapels, for all services. The area selected will be according to availability and information provided by the family or funeral director. Sunset Memorial Park will make every effort to honor specific requests when scheduling and availability permit. The Chapels and Banquet Rooms are handicap accessible.

The Chapels are available daily from 9:00 A.M. to 9:00 P.M. for visitation, committal services and memorial services. The availability of the Chapels on holidays will be at the discretion of Sunset Memorial Park.

Chapel fees include use of arrangement and family rooms, children's area, sound system, organ, microphone, lectern, bier, kneeler, register stand, name pedestal and flower stands.

The officiating funeral director is responsible for providing the necessary staff to coordinate and conduct all visitations, committal services and * memorial services.

2 Hours Use of Banquet Room I and Banquet Room II (Capacity 130)

With use of the Westwood Abbey Chapel or Sunset Chapel	330.00
Without use of the Westwood Abbey Chapel or Sunset Chapel	375.00
<i>Additional hours will be charged at the hourly rate of \$125.00 for each hour.</i>	

A \$75.00 fee will be charged when Chapel Staff is needed for set up/clean up of banquets.

Banquet Room fees do not include beverage or food service. Use of refrigerator, microwave oven and dishwasher is included.

Upon request, catering and food service information is available to the family and funeral director.

If alcoholic beverages are served, the person who has rented the banquet room(s) is responsible for supervision and compliance with all applicable laws.

PERMISSION REQUIRED To protect our property owners, Sunset may require written permission for any placement of remains other than the remains of the property owners(s). Permission may also be required because of the number of spaces owned, or the layout of the property.

PAYMENT OPTIONS Property, merchandise and service fees require payment in full before placement of remains. Before need arrangements are price protected and Sunset offers convenient budget payment plans for all prearrangements. Personal checks, Master Card, American Express and Visa are accepted.

BRONZE MEMORIALS All areas of the Park have specific size requirements for individual and companion memorials. If a bronze memorial is not purchased through Sunset Memorial Park, it is the responsibility of the provider of the memorial to verify all requirements and installation charges with Sunset's office and deliver the memorial to Sunset. The provider of the memorial is also responsible for any addition to the memorial, including future demise dates.

REMOVALS Only the surviving spouse of the deceased may execute the affidavit supplied by Sunset for removal. Any other person requesting removal must secure an order from Probate Court.

NEW DEED and OWNERSHIP CERTIFICATES

Only the property owner(s), or surviving heir's of the property owner(s) may transfer property, merchandise and services.

Personalized merchandise cannot be transferred. When property is transferred, an endowment fee may be charged in addition to deed charges.

It is the responsibility of the property owner(s), prior to any transfer, to verify all applicable transfer charges and procedures with Sunset's office.
